We could all use a break sometimes. This is why we now allow members (for a \$20 processing fee) to skip a payment on qualifying State Credit Union credit cards and loans to use the extra money however necessary. And skipped payments do **not** reflect as missed or late on your credit report!

How it works

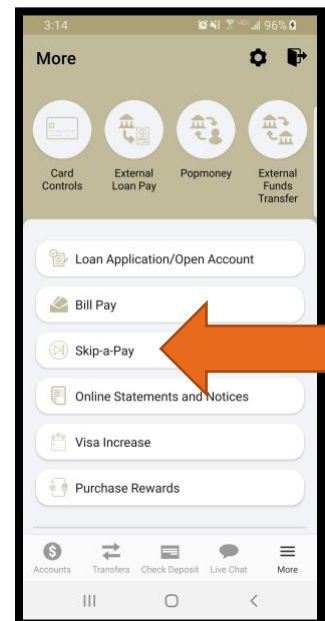
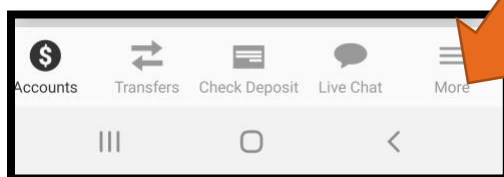
For SCU **loans**, your next payment due date will be pushed forward one month, and the term of your loan will be extended by at least one month.

For SCU **Visa Credit Cards**, the amount due will show as \$0 for the current due date.
